But this is far from the only sort of distressed body. In Section Three, *Discarded and Recovered Bodies* Leder reveals striking parallels between the lifeworlds of animals and prisoners. This stunning collection of essays showcases Leder's powerful and imaginative intellect."

How to Do Things with Dead People Alice Dailey 2022-06-15 How to Do Things with Dead People studies human contrivances for representing and relating to the dead.
