Saturday premium pay should contact his or her Local Union concerning this issue. A. After AFGE filed the grievance, the case went to arbitration. The arbitrator issued a decision in 2005, granting the grievance, ordering the VA to recalculate which positions were entitled to receive Saturday premium pay, and paying back pay to affected employees.

BY ORDER OF THE AIR FORCE INSTRUCTION 36-703 ...

3.1.1. Refusal to reply to questions during an investigation may be the basis for disciplinary action. The employee must be warned that a failure to provide answers may subject them to discipline, including the possibility of removal in appropriate cases, and that any statements cannot be used against them in a criminal prosecution.
